

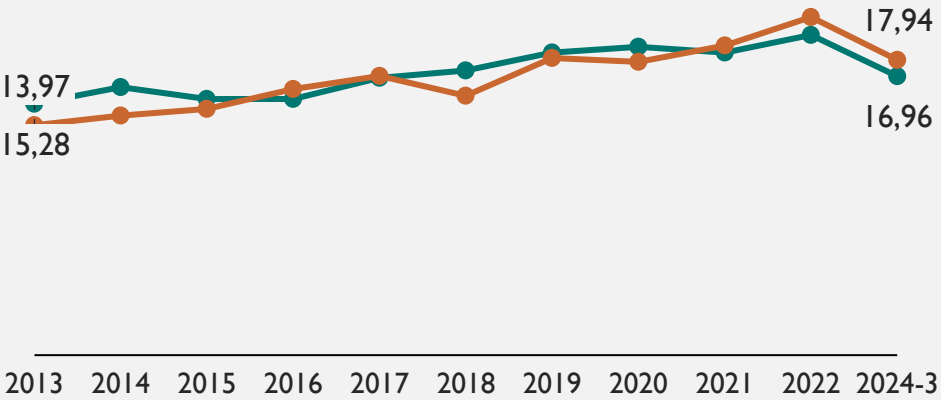

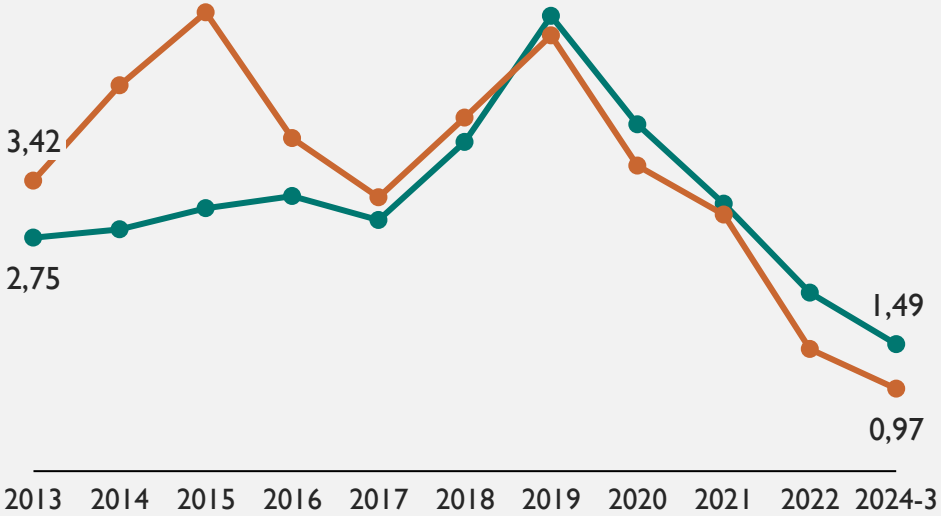

Change in Capital Adequacy Ratio



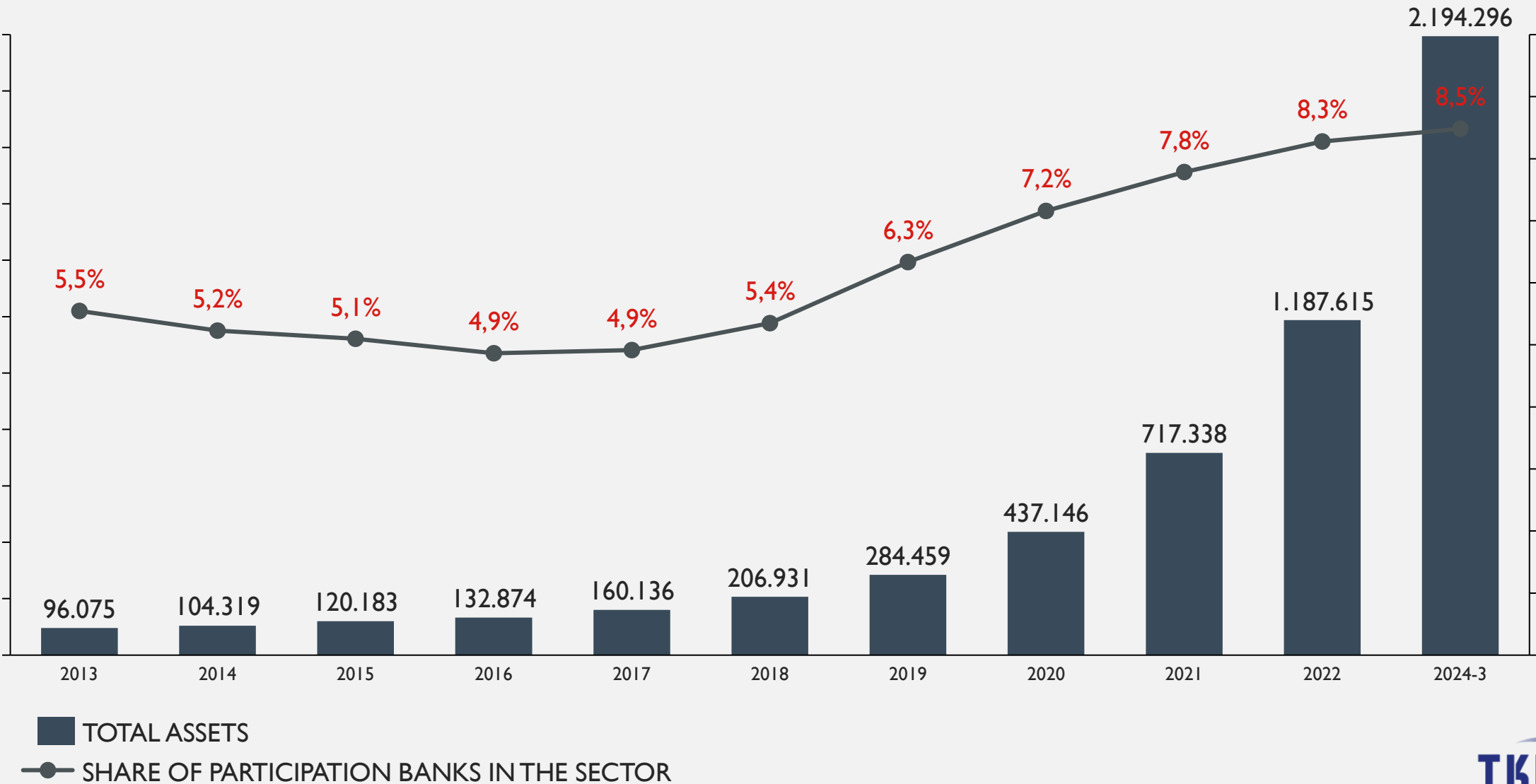
Change in Non-Performing Loans Ratio

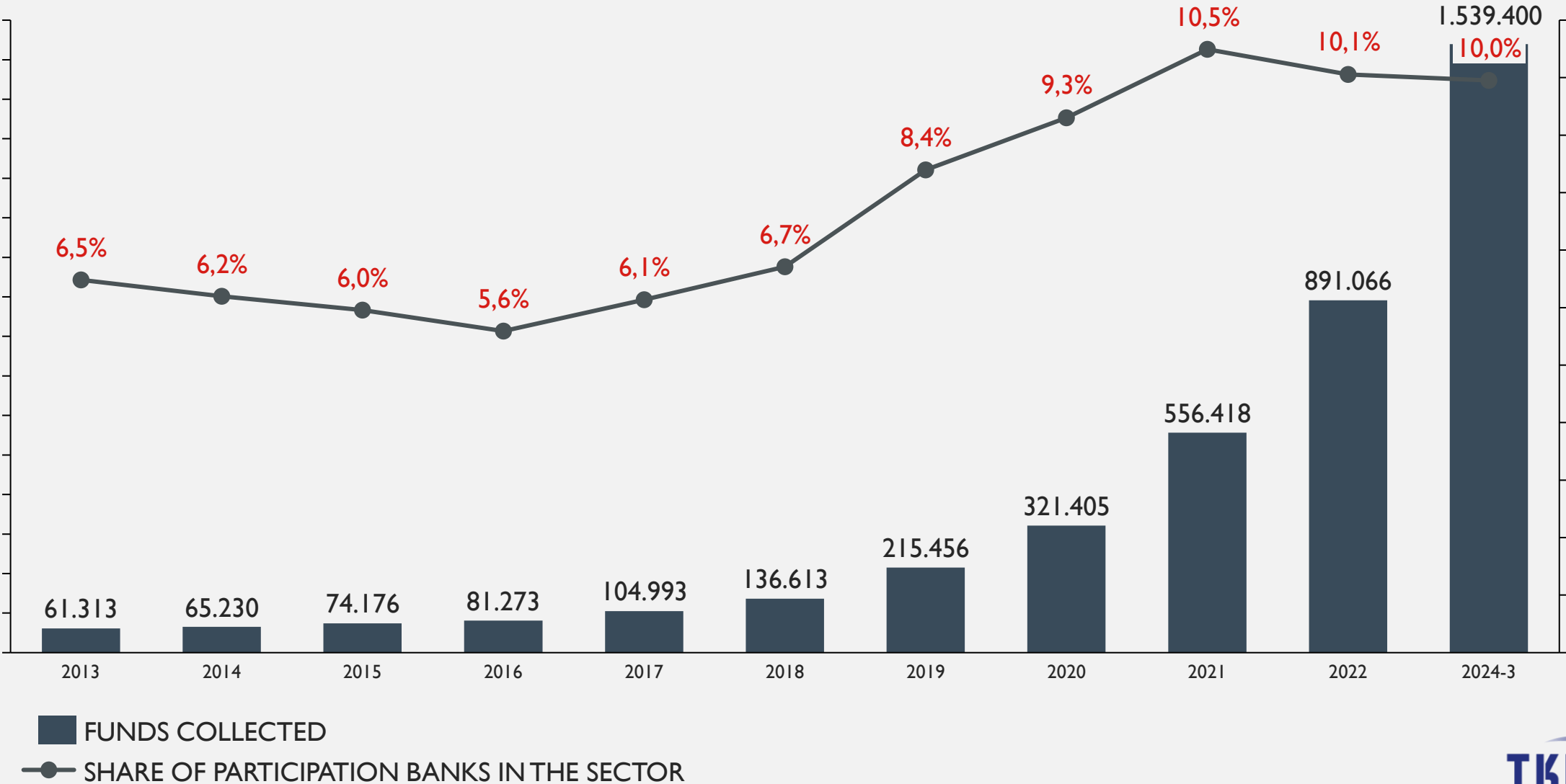
Development of Total Assets of Participation Banks (Million TRY)

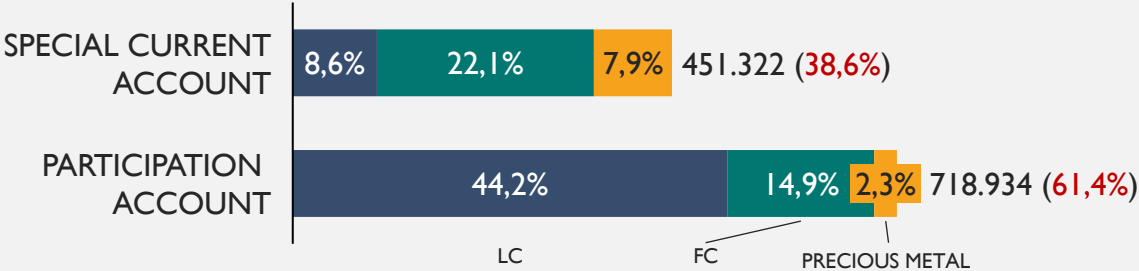
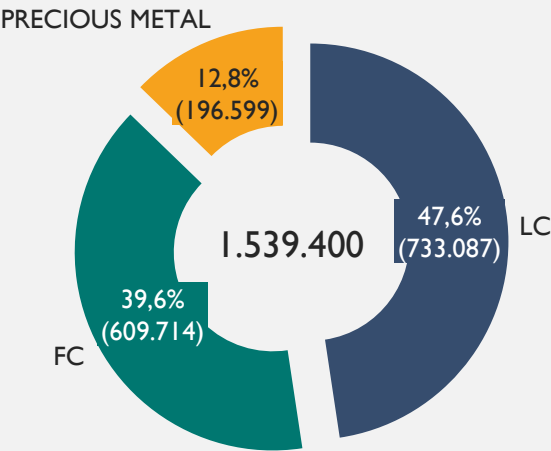


Development of Funds Collected by Participation Banks (Million TRY)

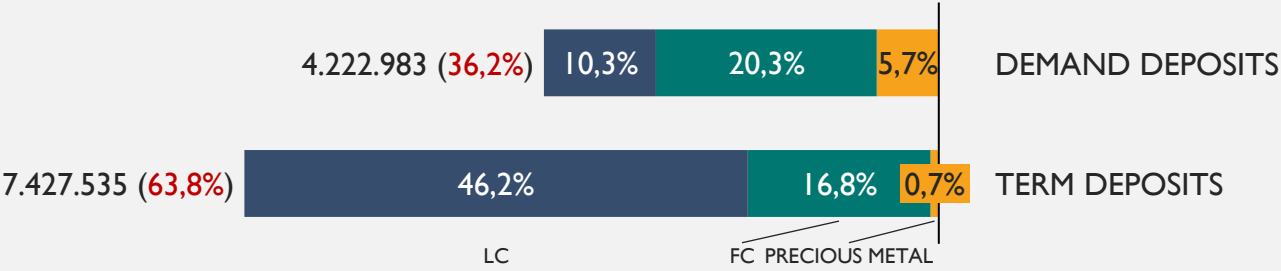
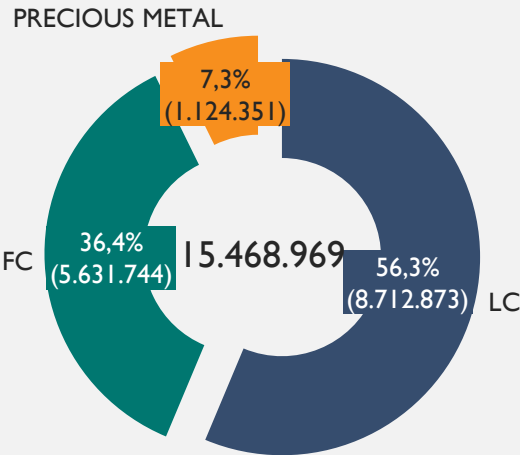

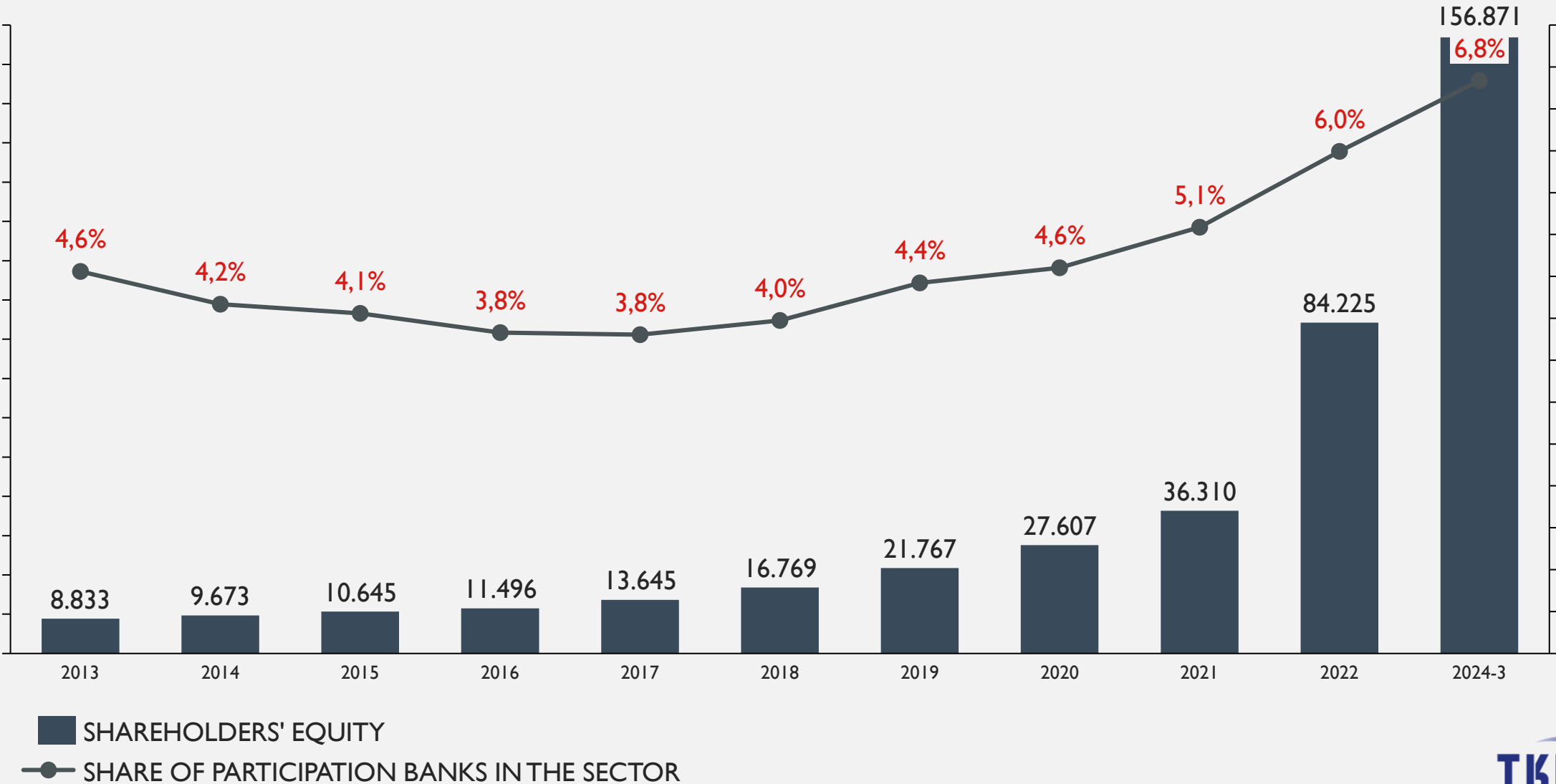






Development of Shareholders' Equity of Participation Banks (Million TRY)
